School Fee Structure

Section 1 - Application Fee

Application Fee of THB 5,000 per child is payable when an application is submitted and is a <u>non-refundable</u> administration charge.

Section 2 - Entrance Fee

The Entrance fee is payable upon initial enrolment and confirmation of the place at the school. This fee is <u>non-refundable</u>. Two options are:

a) Enrolment Fee: One-Time Lump Sum Fee

b) Capital Levy Fee

Capital Levy is an alternative method of paying the enrolment fee. This allows parents who stay in Bangkok for only a short period of time to have a reduced enrolment fee.

Section 11 – School Fee Refund

A refund of tuition fee, canteen fee and transportation fee will only be granted depending on the following conditions: "When a child leaves the school before the next term starts, the parents will be refunded a full term. If the child starts a new term, the parents will be refunded for half term's fees if the child leaves before the half term break. However, if the child attends the second half term but leaves before its end, there is no refund".

Section 12 – Interest Rates for Late Payment

Fees remaining unpaid outside the invoice credit period will be subject to interest of 1.25% per month of outstanding balance until payment is received. The school reserves the right to take any appropriate action in the event of unpaid fee.
